#### **County Criminal Searches**

These searches are conducted manually and will give detailed records including, suspended sentences, probation, and incarceration records.

## State's Repository Criminal Search

In some states, counties submit criminal data to a state repository. This data varies from state to state, some states collect all data from all counties, while other states collect only arrest or felony data. Some states may not provide data to the state in a timely manner and several states may require a signed release to obtain information.

### Federal Criminal Records Search

Violations of Federal law are recorded in U.S. Federal District Courts. While there are fewer violations of Federal laws, they generally involve serious offenses such as embezzlement, robbery, within three years prior to employment. drug trafficking and kidnapping.
